#### 45TH ANNUAL MEETING OCTOBER 21-24, 1974 Amherst, Massachusetts Call for Papers

### Deadline for Submission — July 12, 1974

The submission of contributed papers for presentation at the annual meeting is open to both members and nonmembers of the Society. Suggested topics for contributed papers include (1) Deformations and Relaxations of Solids, (2) Rheology of Multiphase Systems, (3) Flow and Deformation Instabilities, (4) Molecular Rheology, and (5) any topic involving the concepts and applications of rheology.

In addition, a Symposium on *Rheology of Plastics Processing Operations* is being organized by J. L. White (Univ. of Tennessee) and C. Denson (G. E., Louisville). Contributed papers are welcome on such topics as Sheet Forming, Injection Molding, Mixing or other processing operations for which rheological considerations are of primary concern. Inquiries concerning the symposium should be addressed to J. L. White, Polymer Science and Engineering Program, University of Tennessee, Knoxville.

For submission of contributed papers an abstract of 250 words or less is required prior to July 12. All abstracts including the Symposium papers should be sent to:

Those papers intended for the symposium should be so designated. The Program Committee (J. L. Ericksen, A. N. Gent, R. S. Stein, S. S. Sternstein, K. Wissbrun) will review the papers and acceptance will be based on technical content and relevance to rheology, but without regard for the specific topic. Those contributors who choose to submit more than one paper should bear in mind that each abstract will be judged on individual merit.

A Monday evening beer session is planned and several invited lectures will be given on topics of broad general interest to the Society. These will be announced in the next bulletin.

#### Local Arrangements

The meeting is currently being planned for  $3\frac{1}{2}$  days, Monday through Thursday noon, with a buffet supper and bar available Sunday evening. Accomodations will be available Sunday - Wednesday nights, principally at the University Student Center, but with some additional facilities at local motels. In general, meals will be provided, and several quite reasonable registration package options (e.g., accommodations with or without meals) will be available. Pre-registration forms will be mailed to members at a later date. Because relatively inexpensive accommodation and food arrangements are being made on a package basis, everyone planning to attend the meeting is urged to take advantage of the pre-registration procedure, if at all possible.

# ANNUAL BUSINESS MEETING

1. The meeting was called to order at 5:30 p.m. by President Eirich.

2. The minutes of the business meeting in Cincinnati were approved as printed in the Bulletin.

3. President Eirich announced the result of the election of officers. These will be printed in the Bulletin.

4. John Elliot pointed out the present Secretary, John Miller, is retiring and a standing vote of thanks was given for his efforts.

5. E. A. Collins reported that the short course on Rheological Instrumentation was successful. Wm. Grassley was the instructor.

6. Treasurer's report on the 1974 budget was given by E. Collins. The 1972 final accounting was accepted unanimously.

7. R. R. Myers, the Editor, gave his report and it was accepted unanimously.

8. E. A. Collins reported that the 1974 fall meeting will be held at the University of Massachusetts on October 21-23. The possibility of holding a meeting in Hawaii with the Japanese Society of Rheology is being considered.

10. R. S. Marvin, our delegate to the International Committee of Rheology, reported IUPAC has accepted us as an associate member. IUTAM has not acted upon our application.

It appears that the publication of the papers at the Sixth Congress will not be published in toto. The Seventh Congress has not been scheduled, but an invitation to Sweden may be forthcoming.

11. R. S. Rivlin proposed a vote of thanks for F. R. Eirich for his efforts as President of the Society .

12. The meeting was adjourned at 6:30 p.m.

# REPORT BY THE SECRETARY FOR 1973

1. Publication Charges

Vol. 17, No. 1 and 2 of the Transactions will collect about 40% of the publication charges. This rate returns to our previous low after collecting 60% on Volume 16. Improvement in the rate of collection is a necessity.

The Secretary has observed that all authors pay for reprints. This provides no income for the Society, since all the collections go to Interscience.

#### 2. Publications

Two issues of the Rheology Bulletin were published this year. Three issues of the Transactions, Volume 17, were sent to all members. The publishing schedule for the last two years has been excellent, undoubtedly due to the Editor's efforts.

#### 3. Membership

Two technical meetings were held this year. The displaced 1972 Fall meeting in Cincinnati in January and the Fall meeting for 1973 in Montreal.

## 5. AIP Relations

Mrs. Emily Wolfe has retired and AIP has assigned Mrs. Margaret Nightengale to provide assistance at AIP for the Society. Thus far, this has worked out very well. The Society Special Services program has been phased out for the present.

# EXECUTIVE COMMITTEE MEETING

# OCTOBER 28, 1973

1. R. R. Myers was appointed Secretary pro tem in the absence of the Secretary.

2. Minutes of the previous meeting were approved as distributed by the Secretary.

3. Results of the 1973 election were announced:

4. E. A. Collins reported that \$12,000 had been transferred from AIP to the Elyria Savings and Trust Co., Avon Lake, Ohio. The money will earn 6% interest. The Treasurer presented the proposed 1974 budget. This was accepted as proposed.

5. The Secretary's report was read and the contents were accepted as proposed. The Secretary will rewrite the report. A suggestion by the Secretary to raise the price of reprints was deferred.

6. The Editor's report by R. R. Myers is attached. A motion to make the 1974 Transactions 600 pages was proposed, seconded and passed. In response to a question, Myers reported the two track system is still operating. The Editor's report was accepted.

7. E. A. Collins reported that the committee on future meeting sites suggested the University of Massachusetts for 1974. A motion to go to the University of Mass. was made, seconded and passed. Other possible sites for future years were:

Kent State University Sheraton Hotels — anywhere

University of Tennessee in 1974

8. A motion on changing the length of the meeting to 3.5 days was made and seconded. After considerable discussion the motion was passed with two negative votes. The motion is contingent on the ability of the U. of Mass. to accommodate 3.5 days.

9. The committee on future sites is considering a joint meeting with the Society of Rheology in Japan in Hawaii for the winter meeting in 1975.

10. N. Nakajima's report on the Committee Industrial-University Cooperation is attached. Publication of the proceedings of the symposium on Rheological Porblems may be published in the Transactions.

11. Expansion of the program to include branches of rheology other than polymers was discussed. It was suggested that we get rheologists to speak at other societies.

12. E. A. Collins reported that the Rheological Survey was still incomplete.

13. The short course in Instrumentation was successful with 29 attendees and 31 paid.

14. A vote of thanks to Professor Grassley was passed.

15. C. Sieglaff presented the first list of symbols from the Committee on Nomenclature. The list will be considered approved by the Executive Committee if objections are not raised by December 31, 1973.

16. Proposed guidelines for program chairmen presented by E. A. Collins and accepted by a unanimous vote. 17. All information received by the Secretary about other societies should be sent to the Editor.

# REPORT OF THE EDITOR

#### October 26, 1973

#### **Publication** Trends

Volume 17 will amount to 751 pages, comprising 44 manuscripts. Last year I postulated a steady state condition of this order of magnitude, but my prognosis for next year must be adjusted downward for reasons that have no direct bearing on the flow of manuscripts.

Twenty-nine manuscripts were received since January 28, 1973 when I last reported. They were parceled out to the assistant editors who currently are processing 55 manuscripts. In addition, Wiley has eighteen manuscripts on hand.

Quality

Last year we reported that an earlier concern about the quality of papers appearing in the Transactions was unfounded. This condition appears to remain under control. The assistant editors are doing excellent work and we have no dearth of manuscripts from which to select.

#### Prospects for the Future

In the past Michael Harris has occasionally threatened to renogotiate our contract with Wiley. This time the pressure has come from Joseph Kuney, manager of the journal and encyclopedia department, who has stated that an 800-page Volume 18 will have to carry a \$40 price to non-SOR members. I took the liberty of asserting that we would carry only 600 pages in 1974 and would like the Executive Committee to ratify this decision. There was no time for consultation, and in fact my directions to Kuney may have been too late for them to compose a new rate schedule.
