EDWARD B. BAGLEY WINS BINGHAM MEDAL

Dr. E. B. Bagley, Laboratory Chief, U.S. Dept. of Agriculture Engineering & Development Laboratory in Peoria, has been named the 1982 Bingham Medalist of The Society of Rheology.

Dr. Bagley was born in Alberta and received his degrees from the University of Western Ontario (B.Sc. in Chemistry & Physics, with a Gold Medal for exemplary scholarship) in 1950 and from Cornell (Ph.D. in Physical Chemistry) in 1954. He has worked as a research scientist (Canadian Industries Ltd., 1954-64, and U.S.D.A. 1971-75) and as a professor (Washington University 1964-71) before assuming his present

His publications have frequently identified new areas for study and new rheological phenomena. His work on flow instabilities in polymer processing represents an appreciable fraction of our understanding of this subject; he was an early author of studies of melt fracture and the first to show that large discontinuities in the apparent rheological properties may accompany this instability. His work on end corrections in viscometry resulted in an empirical analysis of unusual generality, one which is universally employed by rheologists everywhere, and his studies of die swell, of the effects of molecular weight distribution and of flow instabilities in general stimulated the interest of a host of other scholars once the incisive problem - identification process had been completed. With co-workers H. P. Schreiber and S. H. Storey he observed the fractionation of polymers which occurs in inhomogeneous flows and advanced a quantitative thermodynamic explanation of this phenomenon.

His inventive talents have been recognized with a USDA Distinguished Service Award, an Inventor of the year designation by the Assoc. for the Advancement of Invention and Innovation and an 1R-100 Award - all for his role in the invention of "Super-slurper," a starch graft copolymer with an unusual affinity for water. He has served The Society of Rheology as vice president (1977-79) and president (1979-81) and has coauthored a USDA report for Congress on the feasibility of developing domestic sources of natural rubber.

In summary, Dr. Bagley is recognized as an inventive scholar and scientist. He has been chosen as the 1982 Bingham Medalist on the basis of his unusually innovative contributions to the science of rheology.

Dr. Bagley's lecture Tuesday morning at 9:00 is entitled "Dispersions of Deformable Particles."

MINUTES OF EXECUTIVE COMMITTEE MEETING

March 30, 1982

Members Present: A. Gent, W. Schowalter, R. Myers, J. Collier, E. Collins, E. Bagley, and J. Dealy.

Members Excused: K. Wissbrun

The meeting was called to order at 10:00 AM in the Red Carpet Lounge of the United Airlines area, Cleveland Hopkins airport.

Minutes of the previous meeting (Oct. 11, 1981) were corrected to spell Wawersik correctly, and to indicate the donors supporting the 53rd Annual Meeting were Hercules, General Electric, Rheometrics, and IMass. The corrected Minutes were accepted by a unanimous vote.

Buckley Crist, Jr. informed Dr. Gent by letter and telephone that the Orrington Hotel in Evanston, Illinois (intended meeting location) would be closed for renovation during October 1982. As a result, the Holiday Inn in Evanston (0.7 miles from Northwestern) has been designated as the meeting location. The banquet will be held at the Norris Center at Northwestern University. Program Chairman is Professor A. J. McHugh of the University of Illinois, Urbana. Registration fees for members will be \$25; and non-members will pay a \$45 registration fee which will include their membership dues for the subsequent year.

Professor C. K. Rha of M. I. T. will be in charge of the Short Course on Food Rheology. The emphasis will be on the basics of food rheology. The fee for the two-day course will be \$150 for pre-registrants and \$175 for late registration.

University of Tennessee at Knoxville and California Institute of Technology at Pasadena are being considered as possible meeting sites for the last week in October 1983.

Cal-Tech, Williamsburg, Virginia, and the University of Florida at Gainesville are being considered for this meeting in February 1985 (delayed due to October International Conference in Mexico). The location will be discussed at the October 1982 business meeting of The Society.

The Cleveland-Akron area, Georgia Tech at Atlanta, Lehigh University in Bethlehem, Pennsylvania, Cal Tech, and Williamsburg, Virginia are being considered for October 1985 Annual Meeting.

The possibility of a non-annual Jan. 1984 Winter Meeting was discussed with no conclusion reached.

Professor Art Metzner, University of Delaware, is chairman of the six-member selection committee for the Bingham Medalist and is to report the committee recommendations and basis for choice to the Executive Committee through the President by May 30. The Executive Committee has the final responsibility for the choice. The President can only vote on the selection to break a tie vote.

Each Editorial and Executive Committee member is requested to solicit a paper. Wiley is encouraging the Journal to increase the number of pages at no cost to members. Current circulation is to 1138 members and 670 others. Two sequential issues will be contributed Ferry papers with a February 1, 1983 deadline for papers.

The year end balance for 1981 was \$45,233.15 compared to \$21,497.06 for the previous year. However, this did not include \$8,811.48 for Vol. 25 issues one through six billed in January 1982, increased interest rates (\$3,887), net proceeds from Williamsburg and Louisville (\$5,218), and other adjustment. A reasonable adjusted balance is \$35,000.

The Executive Committee decided only non-profit organizations may receive lists of members, profit organizations should become charter members (\$150) to obtain the lists. Announcements of books and journals can be made by advertisements in the *Journal of Rheology* or *Rheology Bulletin*.

Dr. C. Sieglaff and Professor M. Shaw will be asked to provide a list of services to corporate members for the next Executive Committee meeting.

A request will be made to have the 1988 International Meeting in Canada. The Executive Committee supports this request and will instruct Jack Knox to support it as our representative.

The Executive Committee stated their appreciation for secretarial and related services from AIP and does desire to have AIP continue to collect dues. Representatives to various functions will continue to be appointed. However, the Executive Committee does not agree to pay additional costs to AIP, particularly, since one-third of our dues currently go to A.I.P.

EDITOR'S REPORT

March 12, 1982

JOURNAL OF RHEOLOGY

There were 58 manuscripts submitted to JOR during 1981; of these, plus the 1980 backlog, 46 were accepted and 11 were rejected. Sixteen manuscripts are in the publisher's hands and 31 are in the referee process.

We have until March 29 to supply copy for the August issue which is at the 100-page mark at this writing. We probably will hold at that mark and wait for October to decide if the 1982 volume can be pushed past the 600-page mark. That deadline is May 28, whereas the December deadline is August 2.

Volume 25 (1981) contained 688 pages (33 papers, 11 notes, one addendum, and abstracts from our annual meeting plus JSOR, Japan).

Journal Circulation

There were 1807 subscribers at the end of 1981. Members took 1138 of those, up from 1079 a year ago.

We encountered a possible circulation problem when John Schrag wrote that a Ferry Festschrift was in the making. We responded that we wanted the papers, regardless of how we handle the format. It appears that incorporating the papers in a single enlarged issue will be feasible, especially if that issue is bound and sold separately (as well as given to the members). Suggestions are welcome.

BULLETIN

We issued two bulletins in 1981, and one has emerged in 1982. Final galleys for the latter went to the printer on January 19 and 1300 of the final copies went to AIP in New York on January 22; 100 were sent to Program Chairman McHugh, and one each to the executive committee and session chairmen who had been identified. Exactly one month later our copy arrived from New York, although we learned that other members received theirs earlier.

BINGHAM CERTIFICATES

Those Bingham medalists who were at the Louisville meeting received their certificates from President Bagley. All others received theirs by mail. These small remembrances seemed to be appreciated, for we found a way to secure a response from all of the medalists: we wrote telling them how their name would appear on the certificate if they returned the notice with their approval.

The Executive Committee of the Society has agreed to support the bid for the Congress, and President Gent was invited to be present at the Canadian Group's organizational meeting in Toronto in June. The Group's affairs are currently in the hands of an interim steering committee chaired by John Dealy of McGill University.

The American Institute of Physics has published the AIP 50th Anniversary Physics Vade Mecum, a handbook of equations, data, and formulas from various fields of physics.

Chapter 19, edited by Hershel Markovitz of Carnegie-Mellon University, deals with rheology.

Chapter 13, edited by Ronald Eby of the National Bureau of Standards, covers High Polymer Physics.
