The following agenda items were handled.

- 2. Future Meetings:

The 1984 Annual Meeting will be held the week of February 24, 1985 in Williamsburg, Virginia with Don Baird and Garth Wilkes serving as the Local Arrangements Committee, and Bill Russell and Stuart Kurtz as the Program Chairman and Co-Chairman. # EDITOR'S REPORT THE SOCIETY OF RHEOLOGY

September 20, 1983

Journal of Rheology

Volume 26 (1982) contained 27 articles and five notes; these plus abstracts totaled 620 pages.

Volume 27 already contains 23 articles and one note through Issue 4 of a projected six issues. We received 52 manuscripts, accepted 38, rejected seven, and await action on 42. These figures never total up because the numbers denoting action refer to submissions made up to that time. A disproportionate number of the 42 pending papers will be withdrawn or rejected.

Mary Curtis, new Publisher of Wiley-Interscience Journals, has advised that 700 published pages are planned for Volume 28. Unfortunately, its price to non-members will be \$138. Free subscription to SOR members continues to be a bargain. Outside subscriptions dropped from 1751 to 1741 between 1982 and 1983 as measured in July.

The editorial board will have a chance to meet Ms. Curtis at the Knoxville meeting at a working luncheon scheduled for Monday.

We continue to solicit papers from SOR symposia by offering each symposium chairman the privilege of serving as Guest Editor for the issue which carries the symposium papers. Inasmuch as some of the symposia are a bit peripheral to rheology as measured by the content of some of the papers, we insist that at least two rheologists serve as referees. This practice is working, although the percentage of positive responses is low and certainly not congruent with the fact that the Journal serves as the Transactions of the Society.

For about six years we have published abstracts of papers published in the Journal of the Japanese Society of Rheology. The journal is readily available, but only the abstracts are in English. We are now negotiating with the Australian Branch of the British Society of Rheology to publish abstracts of their biennial (odd-year) meeting papers, which do not enjoy wide circulation.

Rheology Bulletin

Two bulletins issued this year. The August bulletin was sent to AIP on July 20, left their office for the delivery service on August 9, and was mailed from New York at various times, starting apparently around August 16. The combination of two transshipments, two offices being involved, and the involvement of the New York post office in both receipt and sending imposed a delay of at least two weeks in the initial mailing. This delay in itself is tolerable, but the cause of some members not receiving their copies until September clearly is the responsibility of the New York post office.

To address this state of affairs, we have asked our local post office how to secure third-class mailing privileges. Form #3624 indicates that a tax-exempt organization like ours would encounter no difficulty. The Executive Committee will be asked to consider the alternative of mailing bulletins directly from our office. In addition to the form, we must supply 1) our bylaws and constitution; 2) list of officers and directors; 3) our IRS status; and 4) two sample copies of the bulletin. The Cleveland office will then consider the request.

We have initialed correspondence with all foreign societies of rheology known to us (mostly in Europe) to secure notices of meetings. Results are already apparent in the SOR Bulletin.

PACS Revision

Your editor represents the Society of Rheology on an AIP committee for Physics and Astronomy Classification Scheme (PACS). Under the guidance of Gerald Goodman, manager of PACS, a number of suggestions were made that do little to aggrandize the status of rheology. I wrote a stopgap letter concerning the overall outline and will be glad to share it with any member who wishes to have input to the revised PACS. Action is not expected until 1984, and by the time a concerted voice is needed from the SOR, I intend to involve the Assistant Editors. Alternatively, the Executive Committee may want to name a task force to work with me.
