#### 42nd ANNUAL MEETING FALL 1971

#### Time and Place

Monday, October 25 through Wednesday, October 27. University Center, University of Tennessee, Knoxville.

#### Accommodations

University Inn, and Sheraton Motor Inn are within walking distance of the University Center. The Bingham Medal Ceremony and Smoker will be held at the Sheraton Motor Inn Tuesday, October 26.

#### Call for Papers

Submit two copies of a 200-word abstract to the chairman of the Program Committee before July 20, 1971. Equations are to be used sparingly. The Program Committee will review the abstracts for originality, relevance to Society purposes and technical character as a basis for acceptance.

The papers to be presented will be scheduled for 20 minutes followed by 10 minutes for discussion. Projection facilities will be available.

#### Symposium

A one-day symposium, the Rheology of Fibers and Spinning, will be held during the meeting on Monday, October 25. This will include invited and contributed papers on (1) experimental studies and modeling of the spinning process, (2) measurement of elongational viscosity, (3) studies of orientation and crystallization during spinning and drawing and (4) mechanical properties of solid fibers and fabrics. Abstracts for contributed papers in these areas can be sent to D. C. Bogue, Symposium Chairman or J. L. #### CHANGE IN EDITORIAL POLICY

Economics require termination of the practice of supplying free reprints to authors who have not paid page charges.

Moreover, we regret that further austerity measures must be taken, effective with those manuscripts which have not yet been accepted. By vote of the Executive Committee we are now on a two-track system similar to (but more lenient than) the one adopted by our parent organization.

We must maintain a 70% content of paid pages in order to meet our budget responsibilities. Therefore we have requested the publisher to process manuscripts in two categories, depending on which authors honor page charges. As in the past, your editor will not know indentities until after the scheduling.

We hope those authors who cannot secure financial support for their publications will take special pains to be terse.

We will continue the practice of supplying 50 free reprints for those contributors who pay page charges.

#### NOMENCLATURE

After one meeting and an exchange of correspondence the recently appointed Nomenclature Committee has approved some notations which are offered as an interim report by chairman Eirich as follows:

Tentative agreement has been arrived at between most Committee members on the following items: 'Steady Shearing Flow',  $\pi$ , Normal Stress Coefficients', Ø and  $\beta$ ; 'Stress Ratio',  $(p_{11}-p_{22})$  / $_{21}$ ; 'Velocity Gradient',  $\gamma$ ; endorsement for the term 'Intrinsic Viscosity' and rejection of the term, 'Apparent Viscosity'; replacement of 'Real' and 'Imaginary' by 'In-phase' and 'Out-of-Phase'. Work on other definitions relating to Time Dependent, Dynamic, and Second Order quantities is in progress. Anyone who feels very strongly on these points is invited to communicate with the Committee Chairman, F. R. Eirich.

October 25, 1970

- Others Present: A. Metzger, R. A. Mendelson, G. Fulmer, W. Schowalter, D. Bogue, R. S. Marvin.
- 1. The meeting was called to order at 3:00 p.m.
- Minutes of the previous meeting were approved as mailed.
- Editor R. R. Myers made a report on the status of Transactions.
- 4. A meeting with Interscience about the lateness of the Transactions and the number of pages published resulted in a promise to improve the timing and increase the number of pages to 800.
- Upon recommendation of the Editor, a motion to drop free reprints to authors was passed unanimously.
- The Treasurer, R. Coulehan made a report on the finances which were reported to be favorable.
- 7. The Secretary reported that payment of page charges was below 50%, endangering our financial structure if this trend was allowed to go on too long.
- Interscience is requesting that a review of the contract be done in the Spring.
- The subject of the technical program diversity was discussed and while it is desirous to expand to other rheological fields only invited papers were suggested as a means.
- 10. The program for the Winter meeting was discussed by R. A. Mendelson.
- 11. The Local arrangements committee for the Princeton meeting led by W. Schowalter reported that everything was going smoothly and that over 200 rheologists had registered. The financial picture was not clear.
- The Executive Committee passed a motion to thank Messrs. Schowalter and Cakmak.
- J. L. White reported on the local arrangements for the Fall Meeting 1971 in Knoxville.

- R. S. Marvin announced tentative dates for the International Congress in Lyon, France.
- 15. The new membership chairman, Glenn Fulmer gave the suggestion that a special category of membership be developed for retired rheologists.
- Approval for R. Coulehan to set up a charter flight to France was given. Estimated fare is \$200.
- 17. The possibility of a Rheological Survey of rheologists in this country to provide data on rheological work was discussed. A motion to spend \$100 on the survey was passed unanimously.
- A suggestion to hold the Winter 1972 meeting with the Division of High Polymer Physics was discussed.
- A motion to change to Fall meeting for 1972 to January 1973 was passed.
- A fee for invited speakers to meetings was discussed, but no action taken.
- 21. The meeting was adjourned at 6:10 p.m.

- The 1972 International Congress will be held in Lyon, France, September 4-9. A charter flight organized by R. Coulehan was approved.
- 8. The President pointed out that two financial clouds had appeared. A new contract with Interscience must be negotiated and AIP is running a deficit which must be solved by increasing contributions from Societies or decreasing program. A committee with members from every Society has been formed to review AIP programs. The SOR representative is R. S. Marvin.
- Membership in the Society has remained stable for three years. A program to improve the membership appears desirable.

- A vote of thanks was taken for Messrs. Schowalter and Cakmak for the smooth operation of the local arrangements.
- 11. The meeting was adjourned at 6:20 p.m.
