MINUTES OF EXECUTIVE COMMITTEE MEETING OCTOBER 20, 1974

Univ. of Massachusetts, Campus Center, Amherst, MA Executive Committee members present: E. A. Collins,

R. H. Marks (AIP), R. S. Marvin, S. Onogi (Japan Soc. Rheol.), R. S. Porter, W. R. Schowalter, C. Sieglaff, S. S.
Sternstein. The meeting was called to order by the President at 5:10 p.m.

- 1. The minutes of the May 2, 1974, Executive Committee meeting, as printed in the *Bulletin* were submitted by R. A. Mendelson with the following correction: item 3.k. should read, "Industrial-University Relations: under reorganization with J. T. Bergen as chairman." The corrected minutes were approved.
- 2. R. S. Rivlin presented an updated roster of committee appointments, which accompanies these minutes.
- 3. E. A. Collins presented the Treasurer's Report, correcting two errors in the 1973 year-end statement and presenting a 1974 six-month statement. These financial statements are reported separately by the Treasurer. He also suggested that consideration be given to increasing membership dues to \$15, particularly if *Transactions* publication costs rise. The Treasurer's Report was accepted.
- 4. The Editor's Report was presented by R. R. Myers. Three issues of Vol. 18 of *Transactions* comprising 492 pages have been published, and the target of 600 pages will be met with the final issue of the volume. A steady flow of manuscripts are in various stages of processing. Wiley-Interscience has indicated that they wish to double the publication page charges based on member subscriptions (from 3 to 6 mills, adding \$1.80/600 page volume due to this factor alone). The Executive Committee was asked for alternatives and for a policy decision. The Editor's Report was accepted.
- 5. President Rivlin introduced the AIP proposal to publish the *Transactions* as embodied in the letter from R. H. Marks to J. R. Knox, Sept. 27, 1974. Publication charges to the Society would be on an actual cost basis, with the Society accepting the surplus or deficit. AIP estimates indicate a surplus, as opposed to current controlled deficit. Publication format and the premises for the economic estimates were discussed. It was concluded that the validity of AIP's economic forecast is contingent upon AIP's ability to maintain non-member subscriptions. Concern was voiced over the possibility of catastrophic losses should non-member subscription renewals fall drastically.

Marks was instructed to ascertain the legal status of non-member subscription lists and to report to Rivlin. President Rivlin and Editor Myers will then meet with Wiley-Interscience to discuss alternatives. Rivlin will also discuss possible economic guarantees with W. Koch of AIP.

- 6. A motion to publish a membership Directory having the format proposed in Option 2 of the letter of January 26, 1974, from L. Slack (AIP) to F. R. Eirich was adopted. The Secretary was instructed to contact AIP to this effect.
- 7. R. S. Marvin reported on the Swedish acceptance of the host role for the 1976 International Congress on Rheology. He also reported on the admission of the International Committee on Rheology to both the IUPAC and the International Commission on Theoretical and Applied Mechanics. This report of the International Committee was accepted. Rivlin reported that he has appointed N. W. Tschoegl as a delegate to the International Committee with Marvin.
- 8. S. S. Sternstein gave the Program Committee report on the Amherst meeting.
- 9. C. T. Hill reported that local arrangements are underway for the 1975 Annual Meeting in St. Louis. A block of rooms has been reserved at the Chase Park Plaza Hotel.
- R. B. Bird and S. Onogi reported on the program plans for the Joint Meeting of the U. S. and Japanese Societies of Rheology in Honolulu.
- 11. R. S. Porter reported on local arrangements for the Amherst meeting. Registration was currently 165 (Final registration exceeded 200). The report was accepted and the Committee thanked for its work. Rivlin suggested it should be future policy of the Society that non-member invited speakers not be charged a registration fee.
- 12. The 1976 Winter Meeting will be held at the Jack Tar Hotel in San Francisco during the 4th week in January, if a local arrangements committee can be established.
- 13. J. T. Bergen reported on the activities of the Committee on Industrial-University relations. The new committee membership has been established. It is expected that the Monday night session will be continued at the St. Louis meeting.
- 14. G. E. Fulmer reported on membership committee activities. It was agreed to expand the committee size. It was also agreed to exchange membership application forms with the Japan Society of Rheology.
- 15. R. S. Rivlin reviewed the activities of the Committee of Scientific Society Presidents (CSSP) formed to meet with and discuss technical policy of national importance with government officials. Rivlin has been elected Secretary of CSSP for 1975.
- 16. R. S. Stein reported that the Rheo-Optics short course was successfully completed, with 26 registrants, approximately the expected number who could be accommodated. A motion to thank Profs. Stein and Wilkes for their contributions to the short course was unanimously passed.
- R. R. Myers invited the Executive Committee to meet next at Kent State University. The meeting was adjourned at 11:25 p.m.

Univ. of Massachusetts, Campus Center, Amherst, MA The meeting was called to order at 5:20 p.m. by President Rivlin who announced:

1. The Joint Meeting of the U.S. and Japanese Societies

of Rheology.

- 2. The 1975 Annual Meeting in St. Louis.
- 3. The International Congress on Rheology; the 1976 Annual Meeting will be held in the Winter of 1977, probably in New York. (There will be no Fall Meeting in 1976 because of the International Congress); and the 1977 Annual Meeting in Autumn, possibly at Atwood Lake Lodge in Central Ohio.
- 4. Wiley-Interscience's proposed increase in publication charges. This could increase dues; efforts will be made to avoid this, including investigation of a proposal of the American Institute of Physics to take over publication.
- 5. Professor Onogi's indication that the Japanese Society of Rheology would welcome membership applications from the U. S. Society members.
- The Nominating Committee for the 1975 election of Society Officers: F. R. Eirich (Chairman), J. D. Ferry, and D. H. Kaelble.
- 7. Organization of the Committee on Industrial-University Relations with J. T. Bergen as Chairman.

The Secretary's Report for 1974 was given by R. A. Mendelson (to be found elsewhere in the Bulletin) and was approved.

Questions were raised from the floor concerning the AIP publication proposal, and a discussion followed concerning this proposal, the proposed increases in publication charges by Wiley-Interscience, and possible changes in journal format and mode of printing. It was pointed out that a principal reason for current deficits incurred by the *Transactions* is that the rate of honoring of page charges has fallen drastically.

The Treasurer's Report (also found elsewhere in the *Bulletin*) was presented by E. A. Collins and was approved. In addition to presenting the financial statements, it was noted that since 1973 the Society has been receiving interest on its operating balance for the first time.

The Editor's Report was presented by R. R. Myers and was approved. He re-affirmed and explained the mechanism of the two-track publication system involving possible delay of publication of papers for which page charges are not honored. He emphasized that neither the Editor nor the Assistant Editors are aware in which cases pages charges are honored; thus it has no effect on acceptance of papers, but could affect the publisher's schedule. Currently, the rate of publication is such that the two-track has not been activated, but this could change Further details concerning the various proposals for *Transactions* publication were given.

A motion to thank the members of the Program and Local Arrangements Committees for the Amherst meeting was passed.

R. E. Coulehan discussed travel arrangements for the Hawaii meeting and indicated that a mailing with further information and a request for deposits would be forthcoming.

The meeting was adjourned at 6:10 p.m.

1974 REPORT OF THE SECRETARY TO THE ANNUAL BUSINESS MEETING, AMHERST, MA

OCTOBER 21, 1974

Membership Activities:

Two technical meetings were held by the Society in 1974: the Winter Meeting, January 28-30, at Indian Wells, California; and the Annual Fall Meeting, October 21-24, at Amherst, Massachusetts, Twenty-two papers and lectures were presented at the first and seventy-five were presented at the second meeting.

A short course on "Rheo-Optics" was presented by R. S. Stein and G. L. Wilkes, with a guest lecture by Prof. Onogi (Japan Soc. of Rheol.), prior to the Amherst Society of Rheology meeting.

Scheduled meetings for 1975 are the Joint Meeting of the U.S.-Japan Societies of Rheology, June 3-6, in Honolulu, and the Annual Fall Meeting, October 26-30, in St. Louis, Missouri. Membership of the Society in 1974 is 828.

Publications:

Two issues of the *Rheology Bulletin* and three issues of the *Transactions of the Society of Rheology* (Vol. 18), with the latter containing 494 pages, have been published to date. A fourth issue of the *Transactions* bringing total pages to approximately 600 is expected to be published around the end of the year.

The relative merits of continuing to have Wiley-Interscience publish the *Transactions* at an increased cost or to have the American Institute of Physics become the publisher are being examined currently by the Executive Committee.
